Senior Pastor Report - October 8, 2024

The visit from Posaunenchor, our German band friends from Hamm, Germany is almost here, and lots of prep has been going on for this visit. The group is arriving this Friday, and there will be several opportunities to listen to the band: at 3:00 pm on Saturday, October 12 at The Village at Rockville; at 7:30 pm on Saturday, October 12 at PoP; and at our 10:00 am worship service on Sunday, October 13. It's always a great experience to meet and meet again the members of the band and listen to their music, so please plan to be here and bring friends and family!

Confirmation is also fast approaching, and our seven confirmands will read their Faith Statements to Council members on Tuesday, October 15 at 7 pm and Wednesday, October 16 at 7 pm. This has always been a fulfilling experience for Council members, so please be sure to plan to attend one of these evenings. Each session should only last 30-45 minutes. The service of Confirmation will be held on Reformation Sunday, October 27.

The weekend following Posauenchor will also be a big weekend as we'll have our annual Blessing of Pets at the Saturday service on October 19 and the inaugural planting of our Sacred Grounds Garden after worship on Sunday, October 20.

Following our special congregational meeting on Sunday, September 22, work has begun on fixing our HVAC systems. As of this writing, new concrete pads have been installed for the new compressors on both buildings and removal of the old baseboard radiators has begun. Jon can update us more at the meeting on Tuesday. Also, Tom Kettler has completed the reports to the insurance company regarding repairs to the BYC, and Tom even managed to get us some additional insurance reimbursement for work we had done removing dead trees!

As we move into November and December, we'll be quickly moving into many of our traditional Thanksgiving & Christmas lead up events. This will include our All Saints commemorations on November 3; Thanksgiving Adopted Families at the end of November; Advent Evening Prayer on Wednesdays in Advent; and Christmas Pageant (for which there is now a sign-up); and of course, Christmas Eve and Christmas Day worship.

Monthly Financial Summary - September 2024

Statement of Activities

Contributions

Yes, September was a pretty good revenue month however, we still came up short on several key metrics as will be noted. Total revenue was \$23,407 against a plan of \$26,003, under plan by \$2,596.

Expenses

Total expenses were \$28,155 against a plan of \$28,286, under plan by \$131, but over our total revenues for the month by \$4,747. Expenses were in line, for the most part, and total Benevolence payments in the amount of \$1,877 were made.

Deficit

Our deficit went up again in September. The income to expense ratio went from a deficit of \$13,081 at the end of August to a deficit of \$17,286 at the end of September, a \$4,205 increase.

Fund Balance Report

The General Operating Fund stands at \$94,240, a decrease of \$4,747 from August 2024. The Building Fund had total receipts of \$1,868, a disbursement of \$53,055 as the HVAC work began, and an ending balance of \$115,142. The Feast Fund had contributions of \$2,216 no disbursements, and an ending balance of \$20,909. Total revenues/contributions/transfers to all funds from all sources were \$39,772. All other Fund Balances are positive and in good standing.

Cash Activity Report

The adjusted beginning cash balance on September 1, 2024 was \$381,699.27 and the ending balance was \$314,383.86 as of September 30, 2024, a decrease of \$67,315.41 from the end of August 2024. The decrease can be primarily attributed to contractor payments for the HVAC replacement project and Interfaith 5-K disbursements.
